

Ceremony pays tribute to Confederate soldiers who fought for the South

The threat of rain wasn't going to deter Sam Mercer from remembering his Confederate ancestors. After all, he said, they had to dodge bullets even when it was raining and snowing.

"The least we can do is come out and honor them today by being here," Mercer, the Sons of Confederate Veterans' 5th Bridge commander, said Saturday at the Gregg County courthouse during the annual Confederate Heroes Day ceremony.

Members of the Sons of Confederate Veterans, United Daughters of the Confederacy and the Order of the Confederate Rose gathered for the event.

Confederate Heroes Day is an official Texas holiday and is celebrated Jan. 19, Robert E. Lee's birthday. Saturday's ceremony was intended to honor the Confederate soldiers who fought and died during the Civil War, organizers said.

Confederate soldiers "remained the embodiment of all that was good and noble in the Old South," organizers said.

Texas officially seceded from the Union in February 1861.

Longview's Confederate monument was funded by the United Daughters of the Confederacy. UDC President Barbara Gilbert talked Saturday about efforts to honor Confederate veterans in the early 1900s.

"They got together and decided they wanted to do something to help the veterans: put markers at their graves, recognize them if they were still living," she said.

A three-year fundraising effort netted \$3,000 in 1908, and UDC members unveiled the new monument on the birthday of Jefferson Davis. It originally stood where the Glover-Crim Building stands today, but was moved to the courthouse in the 1930s oil boom as more office space was needed, Gilbert said.

The monument, inscribed with the message "Lest We Forget," is a reminder that the South's history needs to be kept, Gilbert said. She noted Saturday that many of the people gathered there were older and that they needed to do more to reach younger generations.

"You need to talk with your children, your grandchildren," she said. "We're going to be down to no one if we don't work with the young people."

Saturday's ceremony included the placing of memorial wreaths, a gun salute and an honor roll call for those who fought for the South. Representatives from numerous East Texas Confederate groups were on hand and encouraged each other to see that the "true history of the South" was presented to future generations.


"They fought and died for Southern rights," 1st Lt. Commander John Hitt said. "We need to continuously honor them."

Mercer said it was important to remember that Confederate soldiers were American soldiers and the Confederate flags were American flags.

"These are American flags carried by American soldiers," he said. "Don't ever forget that."

Texas Secedes

On February 1, 1861, Texas becomes the seventh state to secede from the Union when a state convention votes 166 to 8 in favor of the measure.

The Texans who voted to leave the Union did so over the objections of their governor, Sam Houston. А staunch Unionist, Houston's election in 1859 as governor seemed to indicate that Texas did not share the rising secessionist sentiments of the Southern States. Texas' other move completed the first round of secession. Seven states; South Carolina, Georgia, Florida, Alabama, Mississippi, Louisiana, and Texas left the Union before Lincoln took office.
